- b. Requests in terms of the ACT shall be made in accordance with the prescribed procedures, at therates provided. The forms and tariff are dealt with in paragraphs 6 and 7 of the Act.
- c. Requesters are referred to the Guide in terms of Section 10 which has been compiled by the SouthAfrican Human Rights Commission, which will contain information for the purposes of exercising Constitutional Rights. The Guide is available from the SAHRC.
